Deciding Request for consent Generally</p> <p>1.1 The power pursuant to Section 156(1) of the <i>Heavy Vehicle National Law (South Australia) Act 2013 (the Act)</i>, to, subject to Sections 156(2), (3) (4) and (6) of the Act, if the Regulator asks for the Council's consent to the grant of a mass or dimension authority, decide to give or not to give the consent:</p> <p>1.1.1 within</p> <p>1.1.1 28 days after the request is made, unless Section 156(1)(a)(ii) of the Act applies; or</p> <p>1.1.2 if Section 156 of the Act applies because the Council gave the Regulator a notice of objection to the grant under Section 167 of the Act – 14 days after giving the notice of objection; or</p> <p>1.1.2 within a longer period, of not more than 6 months after the request is made, agreed to by the Regulator.</p>	June 2018	MAI	Nil
